



TERMS AND CONDITIONS  
Plant-based protein Awards for startups

**General**

1. The awards are organised by Le Village by CA North of France (hereafter known as the 'Organiser') whose registered address is Crédit Agricole Nord de France 10 avenue Foch, 59000 Lille, France.
2. By entering the awards, the entrant will be deemed to have read and understood these rules of entry and be bound by them. These include any instructions set out in the Entry Form.
3. The awards are open to anyone involved within the plantbased protein nutrition sector worldwide. Specific entry criteria for each of the award category can be found here. (Link: Village by CA website)
4. To be eligible the project bearer or startup must not have more than 5 years of existence, below 2 million turnover.

**Entry**

5. Any employees (and their families) of the Organiser, its agents and anybody professionally connected with the awards are not eligible for entry.
6. The Organiser reserves the right at its absolute discretion to reject any entry that it deems inappropriate.
8. Entry forms must be completed no later than 21 September 2018.
9. Entries will only be accepted if they are submitted via the entry form, completed.
10. When making your entry online you may email additional information to [levillagebyca@ca-norddefrance.fr](mailto:levillagebyca@ca-norddefrance.fr). If necessary, supporting material can be included with your submission – this could be a Pdf, Word, Excel, PowerPoint or Jpeg file. Please ensure that your full entry submission, including supporting material and logos combined do not exceed the maximum upload limit of 5MB per entry.
11. Entries must be signed by the person responsible for submitting the entry and to whom all correspondence concerning the awards should be addressed.
12. Please ensure that information submitted is accurate and relevant and that project bearer/startups are credited as appropriate.
13. Responsibility cannot be accepted for any lost, late or mislaid entry and any entry which is damaged, defaced, illegible or incomplete, or which otherwise does not comply with these rules of entry may be deemed invalid at the sole discretion of the organiser.
14. All of the finalists will be confirmed in October 2018 at the preselection jury meeting selected by the organiser against the criteria set out in the entry form. Finalists will be notified by email.

15. Finalists will have to pitch their project in front of the Village by CA North of France selection committee on 24th October, in Lille.

16. The winners will be announced at and will be required to attend the awards ceremony and dinner of the 11th Protein Summit.

17. The judges may decline to make some or all of the awards in any category if in their opinion there are insufficient entries of an appropriate standard.

18. The Organiser reserves the right to change the categories without prior notice to entrants.

19. The decision of the selection committee on all matters affecting this competition is final and legally binding.

20. The application is free of charge.

21. Winners may be required to take part in some post-event publicity and consent to their name and photograph being used for such purposes.

22. By entering the awards, all entrants will be deemed to consent to the transfer of their personal data to the data controller for the purposes of the administration of the awards and any other purposes to which the entrant has consented.

23. On the basis of a motivated request by the applicant, travel and accommodation expenses of finalist (for one person, one way and back trip to Lille from the city of origin (plane economy class or train 2<sup>nd</sup> class at the choice of the applicant, as well as a one night stay in a Lille 3\* hotel and food at the venue finalized by the Organizer in relation with the Final Selection session) can be covered fully or partially by Le Village by CA North of France. The Applicant request must be sent by email to the Organizer before 17th October 2018. Village by CA North of France will inform the applicant of its decision to cover the expense and the amount covered before October 20th. All other costs related to the participation to the Final Awards session (additional persons, extras...) are to be borne by the finalist.

### **Judging**

24. For the purposes of judging, all information provided will be treated in the strictest of confidence and will only be viewed by the preselection jury and the selection committee for each category. However, content from your submission may be included in promotional material for the awards.

25. The preselection will be based solely on the information supplied in the entry.
